

San Miguel Collector Card Promotion Privacy Policy and Terms and Conditions

Privacy Policy

- 1. Your personal data (and, if you win a travel, experience or ticket prize for more than one person, the personal data of your guests) will be held by Everards Limited (Everards) and will be shared with Carlsberg UK Limited (Carlsberg) (the "Promoters") only for the purpose of administering the promotion and publicising the winners in accordance with the terms and conditions relating to the promotion ("Terms and Conditions"). The Terms and Conditions are the legal basis for the Promoters' processing. If you do not provide your personal data, the Promoters cannot process your entry, enter you into the promotion or notify you if you are successful in accordance with its obligations under the Terms and Conditions. If your guest(s) do not provide their personal data, then the Promoters cannot include them in the prize.
- 2. If you win a prize, then the Promoters will make your name and county available, as a winner, on one of the Promoters' website and/or to people requesting that information in accordance with the Terms and Conditions, in line with the Promoters' responsibilities under the UK Code of Non-broadcast Advertising and Direct & Promotional Marketing.
- 3. If you win a prize described in the Terms and Conditions (or you are a guest of a prize winner), then the Promoters may ask you to sign a promotional release so that the Promoters may use your name, county and photographs or other recordings of you and your guests in connection with the prize in the Promoters' publicity concerning the promotion and its products, including on (or in) the Promoters' social media pages, websites, press releases and advertising.
- 4. If you are successful (or you are a guest of a prize winner), then the Carlsberg will not keep your personal data for any longer than it needs to, either to comply with the law or to fulfil its obligations to you and other third parties. The Promoters will not disclose or share your personal data (or, if you are a winner, the personal the data of your guest(s)) with any third party other than those who are engaged by the Promoters to administer the competition and fulfil the prizes. Your personal data (and, if you are a winner, the personal data of your guest(s)) may be sent to countries outside of the European Economic Area where the Promoter's (or its third parties') processing equipment is located in another country or where fulfilment of the prize happens in another country but the Promoter will ensure that any transfer happens in accordance with applicable law.
- 6. Entrants (and winners' guests) have various rights with regard to their personal data which the Promoters holds about them:
 - a. a right to request a copy of that data;
 - b. a right to require that the Promoter erases your data (but note that this will automatically remove your entry from the promotion and, if you are a winner or a guest of a winner, will mean that you cannot receive or take up the prize);
 - c. a right to amend your data; and

d. the right to ask us to port (transfer) your data directly to you or another organisation.

Terms and Conditions

Eligibility

- 1. This promotion is open to all persons aged 18 or over and resident in United Kingdom, other than employees, and their immediate families, of Carlsberg UK Limited, their associated companies and anyone else professionally connected with this promotion.
- 2. The Promoter reserves the right to verify the eligibility of entrants. The Promoter may require such information as it considers reasonably necessary for this purpose and a prize may be withheld until the Promoter is satisfied with the verification.

How to Enter

- 3. To enter the promotion you must
 - a. Obtain a collector card (Card) from a participating Everards (Outlet).
 - b. Collect one stamp for each pint of San Miguel purchased from the Outlet that issued the Card. All stamps must be collected at the same Outlet. Bar staff at the Outlet will stamp your Card at the time of purchase. One stamp per person per day please drink responsibly. Normal rules as to the sale of drinks apply.
 - c. Once you have collected four stamps on your Card, complete your details on the Card and submit the completed Card to the Outlet that issued the Card before the Closing Date (defined below).
- 4. The Promoter accepts no responsibility for Cards that are lost for any reason. Forged, damaged, photocopied or altered Cards or stickers will not be accepted.
- 5. Cards and stamps are subject to availability and are non-transferable. No cash or other alternative will be offered.
- 6. The Cards are not to be used in conjunction with any other promotion.
- 7. The instructions provided at the point of entry form part of the terms and conditions of this promotion. In the event of a conflict, these terms and conditions take precedence.
- 8. The promotion starts at 11:00am on 1st January 2019. All entries must be received by the Promoter before the promotion closes at 23:59 on 31st January 2019 (**Closing Date**). The Promoter accepts no responsibility for entries that are lost, delayed, corrupted or not received by the Closing Date for any reason. Proof of sending shall not be deemed to be proof receipt.
- 9. One entry per person. Entries not complying with these terms and conditions will be invalid.

Prize

- 10. There is one prize consisting of a two night stay in London for the winner and one guest at a 4 star hotel on a bed and breakfast basis, with the winner and guest sharing a twin room or equivalent. The prize also includes two tickets to a London theatre show of the winners choice (the **Tickets**) and £200 to cover travel and other expenses.
