PM Boris Johnson announced a 4 phase road map on 22nd February 2021...

This is subject to the following tests:

- Success in progression of the vaccine programme
- Vaccines being effective in reducing hospitalisation and death rate
- Infections not facing a surge
- Assessments of the risks of new variants that cause concern

Johnson added that:

- There will be no curfews for hospitality businesses.
- There will be no need for a substantial meal with an alcoholic drink.
- All restrictions will ease at the same time in all regions.
- Confirmation of each change will be announced one week prior to the date for the next step.

STEP 1: 8th March 2021

- Stay at home orders are still in place.
- Funerals are allowed to take place with 30 in attendance.
- Wakes and weddings can take place with 6 in attendance.
- No household mixing indoors.

29th March 2021

- Rule of 6, or 2 households outdoors.
- No household mixing indoors.
- Minimise travel.
- No holidays.



STEP 2: No earlier than 12th April 2021

Businesses will be given 1 weeks notice period in order to make preparations for reopening.

- Rule of 6 **or** two households outdoors.
- Hospitality can resume **outdoors** only.
- **All retail can operate** (in case you are selling non-essential items).
- **Domestic overnight stays can resume** (with your household only).
- **Self contained accommodation can resume** (this means accommodation where there are no shared bathrooms, entrances/exits, kitchen and sleeping facilities).
- Funerals can take place with 30 people in attendance.
- **Weddings, wakes and receptions can take place with 15 people in attendance.**
- Drive in cinemas are permitted.

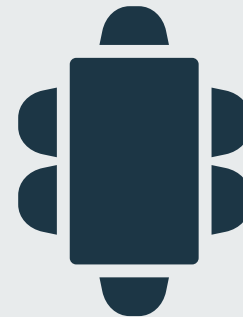


Notes on hospitality venues reopening outdoors:

- No curfew will apply to hospitality businesses.
- Alcohol can be served without a substantial meal (this is no longer a requirement).
- The requirement to order, eat and drink while seated (table service) will remain in place.
- There is no news of whether face masks will need to be worn when moving around the premises but we would say this is highly likely.
- Mitigations like workforce testing will be provided by local councils.

STEP 3: No earlier than 17th May 2021

- **Indoor hospitality services can resume.**
- Indoor entertainment and attractions.
- **30 person limit outdoors** (also applies to outdoor hospitality services).
- **Rule of 6 or two households indoors.**
- **Domestic overnight stays are still permitted.**
- Outdoor entertainment, including performances, are permitted.
- **Significant life events** (including funerals, wakes, wedding and receptions, bah-mitzvahs and christenings) **can take place with 30 guests.**
- Large events include capacity limitations (e.g. indoor events can only comprise of 1,000 people or **50% venue capacity**, outdoor events - 4,000 people of 50% capacity, outdoor seated events - 10,000 or 50% capacity).



Notes on hospitality venues reopening indoors:

- No curfew will apply to hospitality businesses.
- Alcohol can be served without a substantial meal (this is no longer a requirement).
- The requirement to order, eat and drink while seated (table service) will remain in place.
- There is no news of whether face masks will need to be worn when moving around the premises but we would say this is highly likely.
- Mitigations like workforce testing will be provided by local councils.

STEP 4: No earlier than 21st June 2021

- **No legal limits on social contact** - guidance will still be issued to help mitigate infection.
- **Nightclubs can reopen.**
- **No legal limit on all life events.**
- Steps to ensure infection mitigation will still need to be in place even when all adults are offered the vaccine (due to rates of adults taking up the vaccine and also none of the vaccines being 100% effective).
- Covid status certification will take place to assess and confirm the settings that offer a lower risk of transmission.
- The Department for Business, Energy and Industrial Strategy will be exploring the possibility of larger indoor conferences and weddings as we approach June.

Aimed at supporting hospitality, retail and leisure sectors

Funding available

Funding is provided on a per-property basis (according to rateable value).
Granted to closed businesses.
£4,000 for businesses with a rateable value of £15,000 or under.
£6,000 for businesses with a rateable value between £15,000 and £51,000.
£9,000 for businesses with a rateable value of over £51,000.
Funding is available to businesses in the whole of the UK - business support is a devolved policy and therefore the responsibility of the devolved administrations.
